Extract from Clause 10 of the C.C.N.S.W. Constitution

10. Application for membership

- (1) Rules 10(2) to (8) apply to admission to membership of the Club as an Active or Social Member, which means, for the avoidance of doubt, that they do not apply to admission as a Life, Honorary or Temporary Member.
- (2) An application by a person for Active or Social Membership of the Club:
 - (a) must be made in writing, specifying the class of membership for which the applicant applies,
 - (b) must be seconded by an Active Member, and
 - (c) must be lodged (including by email or other electronic means) with the honorary secretary of the Club.
- (3) By making an application for membership of the Club, the applicant agrees;
 - (a) to accept and support the objects of the Club,
 - (b) to be bound by the constitution of the Club, and comply with any Code of Conduct adopted by the Club,
 - (c) to abide by the Laws and Spirit of Cricket whenever they play or participate in any cricket match in which the Club participates or supports, and
 - (d) to pay as and when they fall due the annual subscription or annual social subscription applicable to the class of membership to which they have applied for admissions, and any playing, match fee or charge payable in respect of any cricket match or other activity in which they have played or participated.
